## **QUESTIONS FROM FACULTY**

## Q: What is the status of walk-up virus testing?

**A:** For employees, voluntary asymptomatic COVID-19 testing is available as follows:

University Park: For faculty, instructors, and staff who have been working on campus at University Park, asymptomatic walk-up COVID-19 testing will close at the end of the day on November 11. Beginning immediately and continuing through the month of November, all faculty and staff employees who are in the 'Return to Work' database may take advantage of a new process for voluntary asymptomatic COVID-19 testing. Employees wishing to initiate this process should visit <a href="https://vaulthealth.formstack.com/forms/psuemployee">https://vaulthealth.formstack.com/forms/psuemployee</a>. Test kits will be mailed to home addresses and the test will be completed under virtual observation with Vault Health to complete the process.

University Park in-person testing options will resume after Thanksgiving week. Those details are being planned for December and will be announced soon.

Commonwealth Campuses: For faculty, instructors or staff at Commonwealth Campuses who work on campus and wish to take part in asymptomatic COVID-19 testing prior to the November 20 departure, opt-in voluntary testing via a Vault mail-in kit is available. This program will continue through January 11, 2021. Testing will continue to be available only to employees who are listed in the University's 'Return to Work' database. Employees who wish to participate in the voluntary testing program may do so by visiting <a href="https://vaulthealth.formstack.com/forms/psuemployee">https://vaulthealth.formstack.com/forms/psuemployee</a>. Test kits will be mailed to your home address and you will participate in a virtual appointment with Vault Health to complete the process.

# Q: What testing will be available for students who remain on campuses past November 20, especially during the week of Thanksgiving?

**A:** The University's testing protocols for students and employees, which include walk-up testing and random surveillance testing, will continue through November 20. Due to the holiday, there will be no surveillance or walk-up testing from November 21-29. However,

the University will be prepared to support students with health services for those who remain on campuses over the Thanksgiving week. More specifics for each campus will follow.

All random surveillance testing will resume on campuses on November 30 and continue through the remainder of the fall semester for employees working on site and students who may continue to live on or near Penn State campuses.

## **KEY REMINDERS FOR FACULTY**

 Uncertainties across the world related to the ongoing pandemic – which have made travel difficult in many regions – have led Penn State leaders to <u>suspend</u> <u>all University-affiliated international travel until further notice</u>, and to also strongly discourage personal travel abroad by Penn Staters.

- While Penn State gears up for the end of in-person instruction on November 20, instructors have been planning since the beginning of the fall semester for this 'pivotal' moment. <u>This article</u> provides information about how to assist students with the transition, testing for employees, and more.
- In preparation for departure from campuses after in-person instruction ends on November 20, <u>Penn State has announced an aggressive fall departure plan</u> offering all students COVID-19 testing, at no cost to students. More details about the plan can be found <u>here</u>.
