#### QUESTIONS FROM FACULTY:

# **Q**: How do I share proof of vaccination with the University?

**A:** Employees who perform work at or with the following campuses must be fully vaccinated against COVID-19 and share proof of their vaccination with the University by December 8: Altoona, Behrend, Berks, Brandywine, DuBois, Fayette, Harrisburg, Schuylkill, all Penn State Extension employees across the commonwealth and University Park. Proof of vaccination must be uploaded into the University's <a href="Salesforce Health Cloud">Salesforce Health Cloud</a>, a secure online platform for collecting health data.

# Q: How can I check to see if I uploaded proof of vaccination?

**A:** Faculty and instructors can also check to see if they have uploaded proof of vaccination using Salesforce Health Cloud. Read the full FAQ here.
